



# MOU

This Agreement is made on Dated .....between **Sarvjeet & Sons Chemical Products . Lalganj, Raebareli ,U.P.-229201 India** ,hereinafter called "THE COMPANY", ( Which terms or expression shall unless excluded by or repugnant to the context mean and include its legal representatives, administrators, successors- in – office, executors and assigns) of the ONE PART. AND ..... , **India (GSTIN –.....)** Hereinafter called **SUPER STOCKIST or SS** (Which terms or expression shall unless excluded by or repugnant to the context mean and include its legal representatives, administrators, successors- in – office, executors and assigns) of the OTHER PART. Both the **COMPANY** and the **SS** are jointly referred to as the parties and individually referred to as party. WHEREAS the **COMPANY** is presently engaged in manufacturing and marketing Processed Detergent & other allied products (hereinafter collectively referred to as 'The Products') and where as the **SS** has approached the **COMPANY** for the position of Master Dealerto business with the company. Whereas the **COMPANY** agreed to appoint after considering the Proposal of the above said Party as its MASTER DEALERon the terms and conditions hereinafter appearing. NOW THIS AGREEMENT WITNESSED AND IT IS HEREBY AGREEDE BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. That the COMPANY hereby appoint **M/s....., India (GSTIN –.....)** as Dealer .
2. Dealer will work as BUSSINESS ASSOCIATE of COMPANY as per the area of Dealer signed by the COMPANY for "**Vin Expert**" Brand Products.
3. DEALER area may be reduced or increased on the basis of study and analysis of coverage, service, and business performance of DEALER by management of Company.
- 4.The minimum order value should be convenient load of Goods which will be executed by CSA/ SS company by suitable conveyance on F.O.R. Destination basis at as early as possible on preference basis.
- 5.DEALER will pay **100% Advance** in r/o invoice vide Bank Draft/RTGS/NEFT in favors of Company payable at **Union bank of India ,Lalganj , Raebareli ,U.P. 229206 .**
6. If any shortage or transit breakage found at the time of taking delivery should be informed to CSA or Company within 3(Three) days from the date of receiving the Goods otherwise COMPANY will not be held responsible for payment of such claims.

7. DEALER will ensure the Goods which will be kept in his Go down free from moistures and damp as well as in hygienic condition. If, any damages arise in the absence of this provision, COMPANY will not be held responsible in any way for such damages.

8. Replacement or Return of Goods will be only on condition of manufacturing defects/Breakage/Damage in transit . Or in market on behalf of physical presence of damage goods.

9. DEALER will get the benefit of margin as IN BUILT in ruling PRICE LIST of the COMPANY.

10. COMPANY at his own discretion at any time can change the price structure or Packaging of Jar, Inner pack and outer pack size or design of the products without any prior information to the all Channel Partners .

11. Dealer will deliver the goods to his distributor/Retailer through suitable transport safely to distributor venue or place after getting payment from distributor. **Company will not be responsible for any credit billing ,cash handling by company's Representative** . Dealer has to take care of his operations how to deal with the party on cash or credit however it is suggested to take payment in **Dealer** bank account .

12. Dealer will keep motivating to company's representative posted for his business to retain in the company by achieving the target and will monitor the activity of representative. Dealer will inform to company's management time to time if he observe that any thing is going wrong for company. Dealer will provide the billing, payment and **Stock record on fortnightly basis** to company through mail .

13 **Dealer** will not damage the reputation of company in any way, however he will contribute himself in improving the image of company in market. He will monitor and assist any advertisement process of company which will be run time to time.

14. Dealer will maintain minimum 15 days stock every time .

15. DEALER arrangement can be terminated if the terms & conditions are violated by either party by giving 1(Month) notice and if any accounts/claim left will be cleared within NINETY DAYS of the claim settlement date as per the book of Accounts of the COMPANY / CSA.

16. At the time of break of this arrangement or during notice period, DEALER will issue N.O.C. to COMPANY to appoint new Dealer .

17. Company will have the full right and liberty to appoint another DEALER to keep the continuation of the Business of company if company gets information by any means he is not interested to continue with company.

18. Any Disputes, difference of questions what so ever which will or may arise either during the continuance of this business or afterwards between the company and the "Dealer", touching any clause or things herein contained or any parties here to any way relating to these presents will be referred to a single arbitrator in case the parties agree upon the one , otherwise to three arbitrators, one to be appointed by each of the parties here to and third arbitrator to be appointed by such arbitrators before entering upon the reference and such reference will be constituted as reference under the arbitration and conciliation act.1996.

19. It is hereby express Dealer duly agreed and declared that this conditions will be deem to have been made In Raebareli and that the Civil jurisdiction of Raebareli will have the right to solve all matters arising out of the Agreement and replaces all other understanding, verbal or in writing , between the company and the “Dealer” existing prior to the commencement of this Agreement.
